Dear Processed Food Applicant,

Thank you for your interest in selling processed items at our Markets. The Berkeley Farmers' Markets are sponsored by the Ecology Center, a non-profit organization that has played an important role in the environmental movement since 1969. We are working to develop a more responsible society by identifying environmentally and socially destructive practices and demonstrating sound alternatives. The main focus of the Farmers' Markets is on making fresh, locally grown produce - primarily from small-scale organic farmers - available to the community. For the processed food items we allow in our markets we consider the following criteria:

- 1) Fresh ingredients are in season locally.
- 2) Fresh ingredients are either organic, or are purchased from farmers at the Berkeley Farmers' Markets.
- 3) At least 80% of all other ingredients are organic. Please note that all **sugar, soy, corn, canola, and rice** products must be **certified organic** due to GMO contamination issues.
- 4) Plastic Bag and Packaging Requirements:
 - Bags offered by vendors for use by customers will meet all of the following criteria:
 - Be produced from renewable resources
 - Be free from polyethylene
 - Be compostable (if non-paper, must meet ASTM 6400 standards for compostability)
 - Packaging and utensils offered by vendors will meet all of the following criteria:
 - Be compostable (if non-paper, must meet ASTM 6400 standards for compostability) or produced from non-plastic recyclable material or be a durable, non-plastic container offered with a deposit and intended for return to the vendor for sanitary reuse.
- 5) The producer's business is small-scale and locally based.
- 6) Products are affordable and of high quality.
- 7) The product is made in a commercial kitchen with a current health permit.
- 8) Any other appropriate permits have been obtained. Please contact the Berkeley Health Department at (510) 981-5283 for information on permits required in Berkeley. A Berkeley Health Permit need not be obtained before admission to sell in the Berkeley Farmers' Market.
